## PARLIAMENT

LAW No. 121 of 03-05-2001

## on the additional social protection of certain categories of the population

Published on: 08-05-2001 in the Official Register No. 51 art. 280

## AMENDED LP35 of 29.02.24, MO89-92/05.03.24 art.133; in force from 05.03.24

The Parliament adopts this organic law.

This law establishes the manner of granting additional social protection to certain categories of the population who are citizens of the Republic of Moldova.

**Art 1.-** Starting with May 1, 2001, a monthly allowance for some categories of the population among the beneficiaries of pensions or state social allowances, is established according to the national legislation, and to their families respectively. The categories of persons referred to in art. 2 para. (1) item 3), 3.1) 5), 5.1) 7), 8), 9) and 10) their monthly state allowance is established regardless of whether or not they are beneficiaries of pensions or state social allowances.

**Art.2.** - (1) The amount of the monthly state allowance shall be established according to the category of beneficiaries, as follows:

1) persons with disabilities as a result of the war, intelligence and security officers, persons in the command institutions and in the troops of the internal affairs institutions and in the penitentiary administration system, whose disability is caused by injury, contusion or crippling during the Second World War, as well as during the performance of other military or special service duties, or is caused by conditions associated with being on the frontline of combat operations, in detachments and partisan formations, in illegal organizations and groups during the Second World War:

with severe disabilities – 2050 lei;

with accentuated disabilities – 1900 lei;

with medium disabilities – 1825 lei;

1.1) persons with disabilities among the military, intelligence and security officers, persons in the command institutions and in the troops of the internal affairs institutions and in the prison administration system, whose disability is caused by injury, contusion or crippling in the liquidation of the consequences of the damage at the Chernobyl Nuclear Power Station or is caused by ailments related to participation in the liquidation of the consequences of the damage at the Chernobyl Nuclear Power Station, including persons who have been classified as disabled as a result of participating in the liquidation of the consequences of the damage, being sent on business trips by ministries, departments, enterprises and organizations, as well as persons who have fallen ill with actinic disease or have been classified as disabled as a

result of nuclear experiments, ionized radiation damage and their consequences to civilian or military atomic objectives during the execution of the special or military service, persons who were unable to work in 1986 from the area of alienation and have acquired the citizenship of the Republic of Moldova:

a) with severe disabilities – 1600 lei;

b) with accentuated disabilities – 1450 lei;

c) with medium disabilities – 1375 lei;

1.2) persons with disabilities among the military servants, intelligence and security officers, persons in the command institutions and in the troops of the internal affairs institutions and in the penitentiary administration system, whose disability is caused by injury, contusion or crippling during participation in combat actions for the defense of the territorial integrity and independence of the Republic of Moldova, in combat actions on the territory of other states or in combat actions during times of peace:

a) with severe disabilities – 1850 lei;

b) with accentuated disabilities – 1700 lei;

c) with medium disabilities – 1625 lei;

2) to the participants in the Second World War among the military servants who fulfilled their military service in the army of operations, detachments and partisan formations, among the members of illegal organizations and groups, to the former prisoners in fascist concentration camps and in ghettos in other places of forced detention, created by fascist Germany and its allies during the Second World War, widows of the Heroes of the Soviet Union, persons who worked as civilian employees in the army of operations in the years of the Second World War, persons who were in the city of Leningrad (St. Petersburg) during the blockade (September 8, 1941 - January 27, 1944), persons trained by the local authorities in collecting ammunition and military equipment, demining territory and objects in the years of the Second World War - 1500 lei;

3) to the surviving spouses of participants in the Second World War or in peacetime combat actions, fallen on duty, or of deceased persons with disabilities as a result of the war -1250 lei. The spouse who was married to a person who died during the execution of the service, or as the case may be, deceased, on the date of his or her death, is entitled to the monthly state allowance;

3.1) to the surviving spouse of the deceased participants in the liquidation of the consequences of the damage at the Chernobyl Nuclear Power Station – 1000 lei. The spouse who was married to the deceased person on the date of his or her death is entitled to the monthly state allowance;

4) to the children of participants in the Second World War or in peacetime combat actions, deceased during the military service, or of persons with disabilities as a result of the war, children of participants in the liquidation of the consequences of the damage of the Chernobyl Nuclear Power Station, deceased, before reaching the age of 18 years or after this age, if they continue their studies in educational institutions with frequence until the end of their studies, but only until the age of 23 years is reached, - 1250 lei for each child;

5) to one of the parents of the participants in the combat actions in peacetime or in the combat actions for the defense of the territorial integrity and independence of the Republic of Moldova who died during the military service, of the servicemen who have deceased during the service or died during the fulfillment of the obligations of the military service in the ranks of the Soviet Army or the National Army – 1250 lei. In the case of divorced parents, the amount established, upon request, is equally divided between them;

5.1) to one of the parents of the deceased participants in the liquidation of the consequences of the damage at the Chernobyl Power Station – 1000 lei. In the case of divorced parents the amount determined, upon request, shall be divided equally between them;

6) Persons decorated with orders and medals for hard work and impeccable military service behind the front in the years of the Second World War - 850 lei;

7) persons who have participated in combat actions in Afghanistan, as well as in combat actions on the territories of other states, among the military and civilian members of the Soviet Army, the Military Marine Fleet, state security bodies, collaborators of the internal affairs institutions of the former U.S.S.R.; to workers of these categories who were sent by the institutions of state power of the former U.S.S.R. to other states and who have participated in combat actions on their territory – 1250 lei;

8) military personnel in active service, reservists called up for concentration, volunteers and collaborators of the internal affairs institutions, state security institutions and penitentiary administration system, included in the personnel of military units and special structures in combat positions, as well as the military, collaborators of the internal affairs institutions, state security institutions and the penitentiary administration system and civilian persons delegated to the these units for carrying out special missions in order to ensure the efficiency of combat actions for the defense of the territorial integrity and independence of the Republic of Moldova, to persons trained by the Ministry of Defense in collecting ammunition and military equipment, in demining the territory and objects in the period after the combat actions for the defense of the territorial integrity and independence of the Republic of Moldova -1250 lei;

9) to the rehabilitated victims of the political repressions in the period 1917–1990 – 1000 lei;

10) persons who have participated in the liquidation of the consequences of the damage at the Chernobyl Nuclear Power Station, persons who came in 1986 from the alienation area and received the citizenship of the Republic of Moldova, specified in Law no. 909/1992 on social protection of citizens who suffered from the Chernobyl catastrophe – 1000 lei.

(2) Persons who fall into two or more categories of beneficiaries of monthly state allowances shall be granted only one single allowance of their choice.

**Art. 2.1.** – Annual material aid is established for some categories of citizens as follows:

a) annual material aid for persons with disabilities as a result of participation in combat actions in Afghanistan and for family members of participants who died in combat actions in Afghanistan (spouses and one of their parents) – in the amount of 1000 lei, until February 15. In the case of divorced parents, upon request, the amount established is divided between them in equal parts;

b) annual material aid for persons with disabilities as a result of the actions of the defense of the territorial integrity and independence of the Republic of Moldova and for the family members of the participants who have died on duty during the actions of the defense of the territorial integrity and independence of the Republic of Moldova (spouses and one of the parents) – in the amount of 1000 lei, until March 2. In the case of divorced parents, upon request, the amount established is divided between them in equal parts;

c) annual material aid for persons with disabilities whose disability is caused by the participation in the liquidation of the consequences of the damage at the Chernobyl Nuclear Power Station, for persons who have fallen ill and suffered from actinic disease or have become disabled as a result of nuclear experiments, ionized radiation damage and their consequences to civilian or military atomic objectives during military or special service and for family members to the deceased participants in the liquidation of the consequences of the damage at the Chernobyl Power Station (spouses and one of the parents) – in the amount of 1000 lei, until April 26. In the case of divorced parents, upon request, the amount established is divided between them in equal parts;

d) annual material aid for the participants in the Second World War among the categories specified in art.7 para. (2) item 1) letter a)–e) of Law no. 190/2003 on veterans, for persons with disabilities from the Second World War among the categories specified in art. 8 para. (2) letter a) of the indicated law, as well as for persons who were classified as disabled as a result of injury, contusion, crippling, being trained by the local public administration authorities to collect ammunition and military equipment, to demine the territory and other objects in the years of the Second World War – in the amount of 10000 lei, until May 9;

e) annual material aid for persons affiliated to war participants among the categories specified in art.7 para. (2) item 2) letters a)–c) and e) of Law no. 190/2003 on veterans and for persons trained by local public administration authorities to collect ammunition and military equipment, to demine territory and other objects during the years of the Second World War – in the amount of 5000 lei, until May 9;

f) annual material aid for the surviving spouses of the fallen participants in the Second World War or of the deceased persons with disabilities from the Second World War – in the amount of 1000 lei, until May 9;

g) annual material aid for the victims of political repressions, who were rehabilitated, from 1917 to 1990 – in the amount of 1000 lei, until July 6.

**Art. 3.** – The monthly state allowances and the annual material aid, provided for by this law, shall be established and paid by the state social insurance institutions.

**Art. 3.1.** – The method of establishing and paying the monthly state allowances and the annual material aid, provided for by this law, shall be established by the Government.

**Art. 4.** – The expenses related to the establishment and payment of the monthly state allowances and the annual material aid, provided for by this law, shall be borne from the means of the state budget.

**Art. 5.** - In order to ensure the execution of this law, the Government, within 10 days, shall submit to the Parliament proposals on the amendment of the Budget Law for 2001.
